Trophies & Diplomas: There will be a senior classification, a junior classification and a female classification. Every classification requires a minimum of 4 pilots flying at

least one round. A competitor is considered to be a junior up to and including the calendar year in which he attains the age of 18. Trophies will be given to the first three places.
